## Polk Audio speakers model 7B. Nice!

This auction features a pair of Polk Audio speakers circa 1980's. They are in very good condition. They sound great, and there is nothing wrong with them. This is a two way system, with a dome tweeter, a 6.5" woofer and a 10" passive radiator. The vinyl siding at the rear edge of the cabinets is lifting slightly. Both cabinets are structurally solid. One of the logo's is missing from the grills, as shown in the photos. The speakers feature rubber surrounds, so there is no concern of replacing rotting foam in the next few years. Each speaker measures 24" high, 14" wide, and 9.75" deep. Each weighs 31.25 pounds, so shipping will not be inexpensive. Pick-up at my home is also welcomed. Due to the way I package my items, the weight on each speaker will be closer to 40 pounds. Please see photos. Please feel free to email with questions regarding this item. Please note that I charge actual shipping fees based upon location. I do not charge for packing materials, nor do I charge nonsense "handling" fees. Please note that an email response is expected from the high bidder within three days of auction close. Payment in the form of a PMO or cashiers check is to be received within ten days of being notified of the total with shipping.
